QUESTIONS

The following questions were received in writing prior to the deadline:

Q1: We hold a Class B-1 General Commercial License and a Class A General Commercial License. If we are awarded the project we would hire all applicable trades who would be properly licensed including the Demolition contractor with the Class CR-57 Wrecking license. As we understand the state statute, a Class B-1 and/or Class A General Commercial License allows us to submit this type of work. Does our firm (and anyone submitting on this project) need to hold a Class CR-57 Wrecking license ourselves to be able to submit on this project? Answer: Only a firm not holding a B-1 or A-1 would require a CR-57 license.

Q2: Can an Excess Liability or Umbrella Liability insurance policy be used to meet the insurance limits? Answer: Yes.

Q3: Can you please provide updated links to the Minimum Standards & Rules and Regulations found at the end of the sample contracts? The links provided appear to be broken. Answer: Both the Minimum Standards and Rules and Regulations can be found on the Airport's website under the Policies, Documents and Forms section. Please see link below:
