The Request for Qualifications (RFQ) is modified as set forth in this Addendum. The original RFQ Documents and any previously issued addenda remain in full force and effect, except as modified by this Addendum, which is hereby made part of the RFQ. Offeror shall take this Addendum into consideration when preparing and submitting its Statement of Qualifications. Reponses to questions are in red.

CHANGES

This addendum incorporates the following changes into the RFQ:

1. A Construction Safety and Phasing Plan will be included in the final contract documents as Appendix G.

QUESTIONS

The following questions were asked at the pre-submittal meeting on July 29, 2024:

Q1: Will the TSA have their machines removed by the time the contractor comes into the existing building? Answer: We do not know the exact timing. The Airport will be working with the TSA and in communications with them. We anticipate that when the contractor goes into remodel, the machines will be removed, however, we will know that as the project progresses.

Q2: Is their intent to repurpose the machines? Answer: The CT80s that we currently have will not be used at the Airport. We will be receiving new Leidos machines.

Q3: Are we able to see the site? Answer: There is not a site tour for this solicitation.

Q4: Is there an anticipated budget for the project? Answer: Currently it is approximately \$30 million.

Q5: Is the new building that is going up part of this project? Answer: Yes, including the site prep as the foundation and pad of the building that will be demolished will remain until we are under construction for the new building.

Q6: Is there a start time and completion for the project? Answer: We are estimating a start time of early 2026. For project completion, it depends on how long the CMAR indicates the project will take to build as well as coordinating with the TSA for their portion.

Q7: Is DWL the architect? Answer: Studdiford Technical Solutions is the designer. DWL is a subconsultant to Studdiford.

Q8: Is the Airport looking to any specific integrators or to stay away from any specific integrators? Is there a specific integrator for the PLC system that you would like to continue using or are you looking for new? Answer: We are not far enough along currently to answer that, however, we are going with an entire new system and preliminarily, we plan to connect the existing ticket counter conveyors to the new PLC so the old PLCs will go away.

PROJECT OVERVIEW



Currently, outbound baggage screening at Gateway Airport is accomplished in a semiautomated manner that requires a significant amount of human interaction and has become inefficient with the increase in passenger traffic over the last several years.

The purpose of the project is to construct a new 10,000 square foot building and equip it with an in-line automated Checked Baggage Inspection Station (CBIS) according to the Transportation Security Administration (TSA) Planning Guidelines and Design Standards (PGDS) currently version 8.0.

This solicitation is for Pre-Construction Services with the expectation that the selected firm will participate with the design team and provide input from a constructability point of view. It is anticipated that construction will be funded, and if so, the intention will be to award the construction contract to the firm selected through this solicitation.


LOCATION AND LOGISTICS MAP






CURRENT BAGGAGE CONFIGURATION


