- The Company/Tenant Signatory signing and requesting issuance of the Airport Key is responsible for monitoring the use of that Key. **KEYS ARE ISSUED TO INDIVIDUALS AND CANNOT BE LOANED TO OTHERS.** Keys are the property of the Airport and must be surrendered upon request.
- **The Company/Tenant CANNOT reissue keys to new employees. Airport Operations and Maintenance Office must issue all keys.** The Company/Tenant and the Signatory are responsible for retrieving the key from terminated employees and immediately returning them to the Airport Operations and Maintenance Office.
- Companies are aware that any lost, stolen, or damaged Airport key shall be reported to Airport Operations and Maintenance office immediately.
- **Key applicants MUST present a government issued photo ID and company ID to obtain their key.**
